**Re: Notice of Proposed Real Property Disposition – West of Beacon Street,
South San Francisco**

Dear Tribal Leader:

We are writing to notify you that Pacific Gas and Electric Company (PG&E) plans to sell real estate in South San Francisco. Located West of 139 Marco Way to west of 160 Beacon Street, the property consists of ± 2.2 acres of mostly flat, partially paved, vacant land bisected by Colma Creek. The enclosed Property Information Sheet provides additional factual background relating to the property. PG&E is disposing of the property because it is no longer useful or necessary for our operations. We are offering to sell this because it is Surplus Property.

A record search of the California Native American Heritage Commission's Sacred Lands File has identified the above-referenced property to be within your Tribe's ancestral territory. We are providing this notification consistent with the requirements of the California Public Utilities Commission's Land Disposition Policy adopted December 5, 2019, *Investor-Owned Utility Real Property-Land Disposition – First Right of Refusal for Disposition of Real Property Within the Ancestral Territories of California Native American Tribes*.¹ (the Tribal Land Policy). Under this Policy, the tribe is provided a right of first offer on the real property before PG&E may put the property on the market.

In accordance with the Tribal Land Policy, the tribe has thirty (30) days to respond to this notification as to its interest in acquiring the property by providing a written offer. PG&E supports the Commission's objective of ensuring tribal interests are appropriately considered in any sale of its property. For this reason, we are offering to consult with your Tribe regarding its interest in acquiring the property within the 30 days.

In addition, we appreciate any input, comments or information you would like to share regarding any cultural resources that may exist on the property. We will ensure your input is provided to the Commission as it reviews any future disposition of the property.

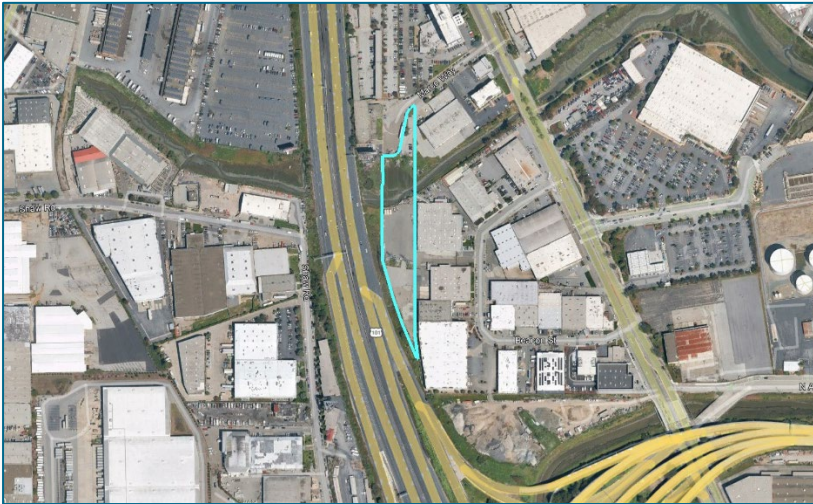

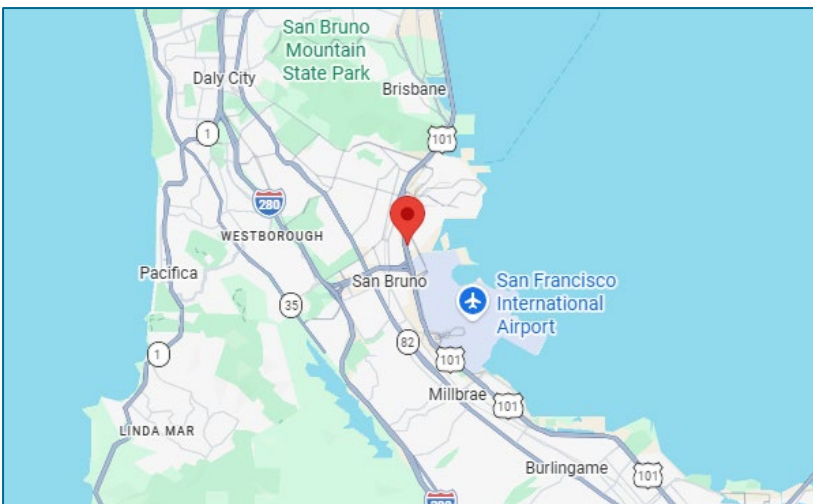
General Plan Designation: East of 101 Mixed Use

Description: Most of this property lies between warehouses along Beacon Street to the east and the Bayshore Freeway 101 to the west. Colma Creek bisects the northern portion which is accessible from Marco Way. The paved portions are currently used for parking and equipment storage.

PG&E Facilities: Six electric towers and their overhead power lines will require an easement.

Environmental: A Phase I Environmental Assessment was completed in April 2026 and found no Recognized Environmental Conditions. A Controlled Recognized Environmental Condition from adjacent 160 Beacon Street was remediated and granted regulatory closure in 2003. No other environmental conditions or issues were found.

Other Notes: Access to the southern portion is by an easement that lies between 130 and 140 Beacon Street.
