Bankruptcy – Plan of Reorganization

- Exited on July 01, 2020

Reorganization Highlights

- Five-year business plan
- Relocating San Francisco headquarters to Oakland, CA
- Creating 5 Operating Area Regions
 - Aligned with local government boundaries
 - Similar geographical and operational characteristics
- Enhanced wildfire safety programs

- 7-Years to comply with all California Geologic Energy Management Division (CalGEM)
