Yuav kom tau txais koj txoj kev txo nqi ntawm txoj kev CARE program mus yav tom ntej, **koj yuav tsum muab kom tau cov ntaub ntawv hauv qab no xa tuaj rau peb tsis pub dhau 45 hnuv suav txij li hnuv uas teev nyob ntawm thawj phab ntawv hauv daim ntawv no.** Thov muab qhov dej num no ua kom tiav raws raim li cov kauj ruam nram qab no.

Mus Thov Koj Daim Ntawv Qhia Nyiaj Khwv Tau Los Uas Tau Muab Xa Mus Rau Tsoom Fwv Qhov Chaw Sau Se Lawm.

Txhua tug neeg laus nyob hauv koj yim neeg leej twg uas tau muab daim ntawv qhia nyiaj khwv tau los ua tiav thiab xa mus rau tsoom fwv qhov chaw sau se nyob rau ob lub xyoo dhau los no yuav tsum tau xa nws ib daim ntawv IRS Form 4506-T mus thov cov ntawv teev nyiaj khwv tau uas nyuam qhuav xa sai sai no los rau nws tug kheej tom qhov chaw sau se. Yog hais tias ib tug neeg hauv yim neeg TSIS TAU xa daim ntawv qhia nyiaj khwv tau los mus rau tsoom fwv qhov chaw sau se, tug neeg ntawd yuav tsum tau xa daim ntawv IRS Form 4506-T no mus thov daim ntawv *Verification of Non-Filing*. **Txhua tus neeg laus nyob hauv yim neeg yuav tsum tau muaj daim ntawv IRS Tax Return Transcript lossis daim ntawv Verification of Non-Filing. Qhov no yog ib qhov uas yuav tsum tau ua txawm hais tias koj twb muab tus neeg laus ntawd suav rau hauv koj daim ntawv se lawm.**

Siv daim ntawv sau npe IRS uas yog daim siv rau qhov dej num no.

Peb xa ib daim ntawv IRS Form 4506-T ua ke nrog ntawm no rau koj tau siv. Yog koj xav tau ntau daim ntawv, muab daim no mus luam lossis mus rau hauv online ntawm www.irs.gov mus rub los rau hauv koj lub computer thiab muab luam tawm los siv. Koj los yeej thov tau daim ntawv teev nyiaj khwv tau los nyob hauv online ntawm www.irs.gov/individuals/order-a-transcript.

Muab koj daim ntawv IRS Form 4506-T xa nrog ntawm no ua kom tiav.

- Muab kab ntawv 1 mus txog kab tawv 4 ua kom tiav.
- Txhob sau dab tsi rau kab ntawv 5.
- Yog koj yuav thov daim ntawv Tax Return Transcript, nyob rau kab ntawv 6, sau tus nab npawb ntawm daim ntawv qhia nyiaj 1040 thiab khij lub kem plaub fab nyob ntawm kab ntawv 6A mus thov koj daim ntawv teev nyiaj khwv tau los.
- Yog koj yeej tsis ua se nyob rau ob lub xyoo dhau los no thiab yuav thov daim ntawv *Verification of Non-Filing*, nyob rau kab ntawv 7, khij lub kem plaub fab nyob ncaj ntawm *Verification of Non-Filing*. Yog tias neb ob niam txiv tau ua se ua ke yav dhau los, tiam sis tam sim no neb ho tsis ua ua ke lawm, neb yuav tsum tau nyias thov rau nyias tus kheej.
- Nyob rau kab ntawv 9, sau lub xyoo rau cov ntawv koj yuav thov. Maub lub xyoo sau zoo li **mm/dd/yyyy** thiab sau hnuv nkawg ntawm lub xyoo them se (piv txwv li 12/31/2017).
- Tsis txhob khij lub kem plaub fab rau kab ntawv 6 thiab 7. IRS yuav muab koj daim ntawv sau npe xa rov tuaj rau koj thiab yuav ua rau qhov no qeeb rau koj.

Xa koj daim ntawv thov mus rau IRS sai sai.

Kos koj lub npe rau daim ntawv IRS Form 4506-T uas koj ua tiav (Thov daim ntawv Transcript of Tax Return lossis Verification of Non-Filing) thiab xa mus rau IRS ntawm: **RAIVS Team, Stop 37106, Fresno, CA 93888**. Qhov chaw IRS yuav nrhiav thiab muab cov ntawv thov feem ntau xa kom tau rov qab tuaj li ntawm 10 hnuv uas yog cov hnuv ua dej ua num.

Tsis txhob xa koj daim ntawv IRS Form 4506-T (Thov Daim Ntawv Teev Nyiaj Khwv Tau Los Nyob Ntawm Daim Ntawv Qhia Nyiaj Khwv Tau Los) mus rau PG&E, vim qhov no yuav muab koj txoj kev los xyuas cov lus teev tseg rau txoj kev pab CARE program kom paub tias yeej yog tag lawm ncuu kom qeeb.

Muab daim ntawv CARE Program High Usage Form ua kom tiav (daim ntawv xim daj xa ua ke nrog ntawm no).

Daim ntawv sau npe no yuav qhia kom koj tau taub txog txhua yam koj yuav tau ua thiab cov dej num uas koj yuav tau ris tam li ib tug neeg nyob rau hauv txoj kev pabcuam CARE program.

2A. Muab daim ntawv High Usage form ua kom tiav (ntus ntawv ntawm ib nrab rov saum).

Xyuas kom meej tias cov lus koj muab sau rau ntawm no yeej zoo ib yam li cov lus nyob hauv koj daim ntawv teev nyiaj khwv tau los. **Muab saib dua ib zaug ntixiv thiab kos koj lub npe rau daim ntawv Kev Hais Tawm (Declaration).**

2B. Muab ntus ntawv uas siv rau kev koom nrog Energy Savings Assistance Program (ntus ntawv ntawm ib nrab rov hauv) ua kom tiav thiab sau npe nkag.
