(Pacific Gas and Electric Company ID U39 E)**

Public Utilities Commission of the State of California

**Subject: Notice of Proposed Construction of Facilities Pursuant to
General Order 131-D, Hammer-Country Club, 60 Kilovolt Power
Line Relocation in the City of Stockton**

Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4 of the construction of facilities that are exempt from a Permit to Construct.¹

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in GO 131-D, Section XI, Subsections B and C.

Background

The Company has been requested by the City of Stockton to relocate a portion of the existing Hammer-Country Club 60 kilovolt power line in the City of Stockton to widen a portion of Hammer Lane and a portion of West Lane. A total of 25 wood poles will be relocated; 3 poles will be relocated approximately ten feet south of their existing location along Hammer Lane from the UPRR grade separation east to Tam O'Shanter Drive, 9 poles will be relocated from the south side of Hammer Lane to the north side of Hammer Lane between Tam O'Shanter Drive and West Lane, 13 poles will be relocated approximately 10 feet east of their existing location along West Lane from two poles south of Swain Road north to three poles north of Hammer Lane. The total length of 60 kV line to be replaced during the relocation is approximately 7,100 feet. Construction is scheduled to begin in April 2002, or as soon as possible thereafter, and the new facilities are planned to be in operation in June 2002.

¹ The Company reserves all legal rights to challenge the decisions or statutes under which it has been required to make this advice filing, and nothing in this advice filing constitutes a waiver of such rights. Also, the Company reserves any additional legal rights to challenge the requirement to make this advice filing by reason of its status as a debtor under Chapter 11 of the Bankruptcy Code, and nothing in this advice filing constitutes a waiver of such rights.

This project qualifies as exempt from Permit to Construct filing requirements pursuant to GO 131-D, Section III, Subsection B.1.f, which exempts, "power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation".

The City of Stockton has issued an Addendum to the Mitigated Negative Declaration and Expanded Initial Study Hammer Lane Phase II and West Lane Widening Project, dated July 2001, and a program Environmental Impact Report was prepared and submitted to the State Clearinghouse in July 1994 (Number 93052058), which includes the proposed power line relocation. No significant unavoidable environmental impacts were identified for the Company's proposed power line relocation.

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs). Based upon the standard that "low cost" mitigation measures not exceed 4% of the total project costs, there are no "no cost" or "low cost" measures to be employed by the Company on this project.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **March 14, 2002**, which is 20 days after the filing date, at the following address:

Persons or groups may protest the proposed construction if they believe that the Company has incorrectly applied for an exemption or that the conditions identified in G.O. 131-D, Section III.B.2, exist.

Effective Date

The Company requests that this advice filing become effective on **April 3, 2002**, which is 40 days after the date of filing. (In accordance with GO 131-D, construction will not begin until 45 days after notice is first published.)
