Pacific Gas and Electric Company (the Company) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

Due to increased electrical demand in rural southwest Fresno County, Pacific Gas and Electric Company (PG&E) is replacing the wires on an existing electric distribution line along the South Lake Avenue alignment approximately 9 miles south of the City of San Joaquin. In order to accommodate the new distribution conductors, PG&E proposes to replace approximately 45 wood poles that also support the existing Stroud Switch Station-Schindler 70 kV Power Line. The pole line extends from the South Lake Avenue intersection with Davis Avenue (approximately 2 miles west of State Route 145, also known as South Lassen Avenue) southerly approximately 2.5 miles. The new poles will be approximately 5 feet taller than the existing poles (replacing existing supporting structures). Construction is tentatively scheduled to begin in November, 2008, or as soon thereafter as possible, and is scheduled for completion in February, 2009, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to

file an application requesting authority to construct. The Company believes this project qualifies for the following exemptions:

- b. the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g. power line facilities or substations to be located in an existing franchise road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Stroud Switch Station-Schindler 70 Kilovolt Power Line Project, County of Fresno

Proposed Project: Due to increased electrical demand in rural southwest Fresno County, Pacific Gas and Electric Company (PG&E) is replacing the wires on an existing electric distribution line along the South Lake Avenue alignment approximately 9 miles south of the City of San Joaquin. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- b. the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
