Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Kearney-Biola 70kV Pole Replacement Project, City of Fresno, County of Fresno

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order ("G.O.") 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate the installation of a second distribution circuit attached to poles below the Kearney-Biola 70 Kilovolt (70kV) power line in the City of Fresno, Pacific Gas and Electric Company (PG&E) will replace approximately 9 wood poles (varying approximately 45 to 60 feet in height) with approximately 8 new light-duty steel poles (replacement of existing facilities) that will be approximately 10- to 25-feet taller (to accommodate for conductor clearances needed for the installation of the second distribution circuit) which will give the power line a uniform height of approximately 70 feet above ground level; except for the most westerly pole that is currently 70 feet and will increase approximately 12 feet in height. The power line is located in an existing PG&E easement (public utility easement) and begins approximately 300 feet east of the intersection of Polk Avenue and Ashlan Avenue in the City of Fresno, and extends easterly along the northerly side of Ashlan Avenue for approximately 2,350 feet to the northeast corner of Ashlan Avenue and Cornelia Avenue. There will be no increase in the capacity of the power lines. Work is scheduled to begin in September 2010, or as soon thereafter as possible, and will be completed by May 2011, or as soon thereafter as possible.

CPUC General Order 131-D, Section III, Subsection B.1., exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s):

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.

- g) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by **July 13, 2010**, which is 20 days after the date of this filing. Protests should be mailed to the following address:

NOTICE OF PROPOSED CONSTRUCTION

PROJECT NAME: Kearney-Biola 70kV Pole Replacement Project, City of Fresno
ADVICE LETTER NUMBER: 3695-E

Proposed Project: In order to accommodate the installation of a second distribution circuit attached to poles below the Kearney-Biola 70 Kilovolt (70kV) power line in the City of Fresno, Pacific Gas and Electric Company (PG&E) will replace approximately 9 wood poles (varying approximately 45 to 60 feet in height) with approximately 8 new light-duty steel poles (replacement of existing facilities) that will be approximately 10- to 25-feet taller (to accommodate for conductor clearances needed for the installation of the second distribution circuit) which will give the power line a uniform height of approximately 70 feet above ground level; except for the most westerly pole that is currently 70 feet and will increase approximately 12 feet in height. The power line is located in an existing PG&E easement (public utility easement) and begins approximately 300 feet east of the intersection of Polk Avenue and Ashlan Avenue in the City of Fresno, and extends easterly along the northerly side of Ashlan Avenue for approximately 2,350 feet to the northeast corner of Ashlan Avenue and Cornelia Avenue. There will be no increase in the capacity of the power lines. Work is scheduled to begin in September 2010, or as soon thereafter as possible, and will be completed by May 2011, or as soon thereafter as possible.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1 exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption(s):

- b) The replacement of existing power line facilities or supporting structures with equivalent facilities or structures.
- g) Power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR finds no significant unavoidable environmental impacts.

Public Review Process: Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.

Within 30 days after Pacific Gas and Electric Company has submitted its response, the Executive Director of the CPUC will send you a copy of an Executive Resolution granting or denying the request and stating the reasons for the decision.
