Pacific Gas and Electric Company ("PG&E") hereby submits this advice letter requesting a modification to the existing "Agreement Between San Francisco Bay Area Rapid Transit District and Pacific Gas and Electric Company for Specified CPUC Jurisdictional Electrical Services" ("Agreement").

Purpose

The purpose of this filing is to modify Exhibits "B" and "C" of the Agreement to update the list to include new power delivery locations for the San Francisco Bay Area Rapid Transit District ("BART"). These modifications are necessary to accommodate BART's request to update Exhibit B, "Station Power Locations," to include the newly constructed West Dublin Station and Exhibit C, "Miscellaneous Power Locations," to include the Oakland Shop Annex.

Background

BART takes Network Integration Transmission Service ("NITS") under PG&E's Federal Energy Regulatory Commission ("FERC") jurisdictional Open Access Transmission ("OAT") tariff. In conjunction with the NITS, PG&E provides certain services to BART pursuant to the Agreement. The Agreement was the result of Investigation and Suspension ("I&S") Case No. 99-06-002. PG&E filed the Agreement on behalf of both BART and PG&E, and the California Public Utilities Commission ("CPUC" or "Commission") approved the Agreement in Decision ("D.") 00-10-015 dated October 5, 2000.

On November 1, 2010, PG&E filed at FERC revisions to the NITS under PG&E's OAT tariff to reflect BART's newly constructed West Dublin Station and Oakland Shop Annex

(Docket No. ER11-01983-000). PG&E requested that the modifications have an effective date of January 1, 2011.

Modifications to the Agreement

PG&E is requesting that the West Dublin Station be added to Exhibit B, "Station Power Locations," and the Oakland Shop Annex be added to Exhibit C, "Miscellaneous Power Locations," of the Agreement. This filing will not affect any rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.
