Subject: Add One New Site to Hazardous Substance Mechanism

Purpose

Pacific Gas and Electric Company (PG&E) hereby requests California Public Utilities Commission (Commission) approval to include one additional site in the Hazardous Substance Cost Recovery Account as referenced within Gas Preliminary Statement Part AN and Electric Preliminary Statement Part S, *Hazardous Substance*, in compliance with Decision (D.) 94-05-020. PG&E has identified the following facility with hydrocarbon contamination which likely occurred during operation of the gas line prior to PG&E's ownership in 1959 or shortly thereafter. PG&E plans to investigate the lateral and vertical extents of the impact to determine likely further actions, and remediate as necessary. A description of the site is set forth in Attachment I to this filing. The site is as follows:

Background

D. 94-05-020 requires California utilities to file an advice letter in order to include additional sites as part of the Hazardous Substance Mechanism. For each site the advice letter shall list: 1) the name of the site(s); 2) the location of the site(s); 3) the source, nature and approximate date of the contamination; 4) utility operations (historical and current) at the site(s), if any; and 5) environmental agency actions and oversight regarding the site(s), if any. In addition, D. 96-07-016 requires utilities to demonstrate that: 1) clean-up costs

for which recovery is being sought are not being recovered through base rates or through any other recovery procedure, and 2) all of the costs for which recovery is being sought are hazardous waste clean-up costs (including insurance costs) found appropriate for recovery in the Collaborative Report.

Protests

Anyone wishing to protest this filing may do so by sending a letter by June 19, 2013, which is 20 days from the date of this filing. The protest must state the grounds upon which it is based, including such items as financial and service impact, and should be submitted expeditiously. Protests should be mailed to:

Source, Nature, and Approximate Date of Contamination: Hydrocarbon contamination has likely been caused by releases of gas condensate from the operation of the gas line prior to PG&E's ownership in 1959, or shortly thereafter.

Utility Operations at the Site: Line 57A was purchased from Standard Oil in 1959 and has been used as a natural gas transmission line. Currently, Line 57A starts at Old River Pressure Limiting Station and carries natural gas coming from McDonald Island to PG&E's Brentwood Gas Terminal facility.

Environmental Agency Actions: No agency involvement to date.

Nature of Costs: The cleanup costs for which PG&E is seeking HSM recovery are not being recovered in base rates or through any other recovery procedure. All cleanup costs to be recorded by PG&E in the HSM memorandum accounts will be hazardous substance cleanup costs found appropriate for recovery in the Hazardous Substance Cleanup Cost Recovery Collaborative Report.
