**Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Atascadero-San Luis Obispo 70 kV Power Line Relocation in the County of San Luis Obispo**

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

PG&E has been requested to relocate approximately 1,995 feet (minor relocation) of the Atascadero-San Luis Obispo 70 Kilovolt (kV) Power Line in San Luis Obispo County to accommodate future development plans for the City of Atascadero's Eagle Ranch Specific Plan. The relocated segment begins approximately 524 feet northwest of the intersection of Atascadero Avenue and Santa Barbara Road. The current alignment goes southeast up and over an existing knoll. The relocation would direct the line first east then south, arching around the base of the east side of the knoll along an existing dirt road, and tying back into the existing line in a wooded area approximately 1,000 feet south of Atascadero Road and 500 feet west of Highway 101. To provide adequate ground-to-wire clearances in the new location and provide additional strength, PG&E will replace seven approximately 45- to 55-foot-tall wood poles with seven approximately 52- to 77-foot-tall light-duty-steel poles, which are weathered to resemble wood. Five of the existing wood poles will remain in place and will be shortened to accommodate the existing distribution underbuild until the property is developed. Work is scheduled to begin in August 2013, or as soon thereafter

as possible, and will be completed in September 2013, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by July 23, 2013, which is 20 days after the date of this filing. Protests should be mailed to the following address:

**Exemption from CPUC Permit Requirement:** CPUC General Order 131-D, Section III, B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. Pacific Gas and Electric Company believes this project qualifies for the following exemption:

- c. the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures.

**Public Review Process:** Persons or groups may protest the proposed construction if they believe that Pacific Gas and Electric Company has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
