Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The developer of Lost Hills Solar Project in Kern County has requested that Pacific Gas and Electric Company (PG&E) connect the existing Arco-Carneras 70 Kilovolt (kV) Power Line to the solar project's substation. The substation is located approximately 3,700 feet northeast of the intersection of State Route 33 and State Route 46.

PG&E will replace two existing 45-foot-tall wood poles with two new tubular-steel poles (existing easement). PG&E will add one new tubular-steel pole on the existing line (existing easement, intersetting additional structures). The three new poles will be approximately 70 to 80 feet tall to meet California Public Utilities Commission (CPUC) General Order 95 minimum clearance requirements. The poles will also meet current design standards, and one pole will support switches. One existing 56-foot-tall wood pole will be shortened to support existing distribution wires. Construction is tentatively scheduled to begin in October 2014, or as soon as project plans and approvals are in place. Construction is

tentatively scheduled to be completed in December 2014, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts a utility from the CPUC's requirement to file an application requesting authority to construct if a project meets specific conditions. This project qualifies for the following exemption(s),

- c. "the minor relocation of existing power line facilities up to 2,000 feet in length, or the intersetting of additional support structures between existing support structures."

- g. "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Anyone wishing to protest this filing may do so by filing a protest with the CPUC and the Company by April 23, 2014, which is 20 days after the date of this filing. Protests should be mailed to the following address:

Proposed Project: The developer of Lost Hills Solar Project in Kern County has requested that Pacific Gas and Electric Company (PG&E) connect the existing Arco-Carneras 70 Kilovolt (kV) Power Line to the solar project's substation. "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

Public Review Process: Individuals or groups may protest the proposed construction if they believe that PG&E has incorrectly applied for an exemption or that the following conditions set out in Section III.B.2 of General Order 131-D exist:

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies;
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
