Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Old River One Solar Interconnection Project (Kern County)

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

The developer of Old River One Solar Project has requested that PG&E connect the existing Kern-Old River 70 Kilovolt (kV) Power Line to the solar project's substation (larger project CEQA). The substation is located approximately 1,500 feet southeast of the intersection of Gosford and Shafter Roads in Kern County. The developer will construct and transfer to PG&E an approximately 3,000-foot-long 70 kV power line between the substation and the existing Kern-Old River 70 kV Power Line. The new power line will begin at the substation and run northerly for approximately 400 feet to Shafter Road, where it will continue west for approximately 2,700 feet to interconnect with the existing Kern Old River 70 kV Power Line. The majority of the power line will be installed on approximately 12 light-duty steel and tubular-steel poles ranging in height from approximately 45 feet to 85 feet tall. Approximately 470 feet of the power line will be installed underground where it crosses under an existing 500 kV transmission line. At the point of interconnection, PG&E will replace one existing approximately 70-foot-tall wood pole with one new tubular-steel pole (existing easement). This new pole will be approximately 95 feet tall to support three switches, meet current design standards, and comply with California Public Utilities Commission (CPUC)

General Order 95 minimum clearance requirements. Construction is tentatively scheduled to begin in October 2014, or as soon as project plans and approvals are in place. Construction is scheduled to be completed in December 2014, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- f. "power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation."

The County of Kern adopted an Environmental Impact Report and Addendum for the Old River One and Old River Two Solar Project, finding no significant unavoidable environmental impacts resulting from PG&E's proposed facilities (State Clearinghouse #2010121058).

- g. "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

Additionally, G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs) in accordance with CPUC Decision 06-01-042 and the "EMF Guidelines for Electrical Facilities." The following measures are proposed for this project:

Increase the height of overhead lines in residential areas, more than otherwise required, to reduce EMF strength at ground level.

This filing will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

Effective Date

The Company requests that this advice filing become effective on August 23, 2014, which is 30 days after the date of filing. (In accordance with G.O. 131-D, construction will not begin until 45 days after notice is first published.)

Proposed Project: The developer of Old River One Solar Project has requested that Pacific Gas and Electric Company (PG&E) connect the existing Kern-Old River 70 Kilovolt (kV) Power Line to the solar project's substation (larger project CEQA). The substation is located approximately 1,500 feet southeast of the intersection of Gosford and Shafter Roads in Kern County. Electric and Magnetic Fields (EMF): PG&E will employ "no cost" and specified "low cost" measures to reduce public exposure to EMF in accordance with California Public Utilities Commission (CPUC) Decision 06-01-042 and PG&E's "EMF Design Guidelines for Electrical Facilities." The following measures are proposed for this project:

- Increase the height of overhead lines in residential areas, more than otherwise required, to reduce EMF strength at ground level.

Exemption from CPUC Permit Requirement: CPUC General Order 131-D, Section III, B.1, exempts a utility from the CPUC's requirement to file an application requesting authority to construct if a project meets specific conditions. This project qualifies for the following exemption(s):

- f. "power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation."

The County of Kern adopted an Environmental Impact Report and Addendum for the Old River One and Old River Two Solar Project, finding no significant unavoidable environmental impacts resulting from PG&E's proposed facilities (State Clearinghouse #2010121058).

- g. "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

Public Review Process: Individuals or groups may protest the proposed construction if they believe that PG&E has incorrectly applied for an exemption or that the conditions set out in Section III.B.2 of General Order 131-D exist;

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
