Purpose

On August 14, 2014, the California Public Utilities Commission (Commission or CPUC) issued Decision (D.) 14-08-032 in Pacific Gas and Electric Company's (PG&E) 2014 General Rate Case (GRC). In that decision, the CPUC requires PG&E to establish a new account and to track the difference in actual capital expenditures incurred for the replacement of San Francisco incandescent streetlights "during the 2014-2016 GRC cycle" versus the 2014 forecasted capital cost amount of \$7.24 million.¹

The affected tariff sheets are listed on the enclosed Attachment 1.

Background

On November 15, 2012, PG&E filed its 2014 GRC Application (A.) 12-11-009. In this application, PG&E proposed generation and distribution base revenue requirements for test year 2014 and attrition years 2015 and 2016. On April 18, 2013, the CPUC issued D.13-04-023 granting PG&E's proposal to make its 2014 GRC revenue requirement effective January 1, 2014, including interest covering the period subsequent to January 1, 2014.² On August 14, 2014, the CPUC issued final D.14-08-032 in PG&E's 2014 GRC adopting base revenue requirements for the 2014-2016 GRC period.

Tariff Revisions

Establish Electric Preliminary Statement Part GN – *San Francisco Incandescent Streetlight Replacement Account (SFSRA)*, to record an entry, if necessary, for the

revenue requirements associated with un-spent capital expenditures for the replacement of San Francisco streetlights at the end of the 2014-2016 General Rate Case (GRC) period. PG&E does not expect to need to make an entry to the Streetlight Replacement account, Electric Preliminary Statement Part GN.

The filing would not increase any current rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

- GN. San Francisco Incandescent Streetlight Replacement Account (SFSRA) (N)
1. PURPOSE: This account records an entry for the revenue requirements associated with un-spent capital expenditures for the replacement of San Francisco streetlights at the end of the 2014-2016 General Rate Case (GRC) period. Over the 2014 through 2016 GRC period, PG&E will track the difference between capital expenditures incurred and the 2014 adopted forecasted capital cost amount of \$7.24 million. To the extent that capital expenditures incurred are lower than the adopted forecast, at the end of the GRC cycle PG&E will record to this account a credit for the difference between revenue requirements based on actual costs and the adopted forecast. PG&E is not required to track amounts once spending reaches the adopted forecast. (N)
 2. APPLICABILITY: The SFSRA shall apply to all customer classes, except for those schedules or contracts specifically excluded by the Commission.
 3. REVISION DATE: Disposition of any over-collected balance in this account shall be in the next GRC, or as otherwise authorized by the Commission.
 4. RATES: The SFSRA does not have a rate component.
 5. ACCOUNTING PROCEDURE: PG&E shall make the following entry to the SFSRA at the end of the 2014-2016 GRC period as follows:
 - a) A credit entry equal to the revenue requirement associated with the 2014 adopted capital forecast, excluding the allowance for Franchise Fees and Uncollectible Accounts expense (FF&U).
 - b) A debit entry equal to the capital-related revenue requirement, excluding Franchise Fees and Uncollectible Allowance Expense (FF&U), related to the actual capital costs incurred. Capital-related revenue requirements include depreciation expense, the return on investment, federal and state income taxes, and property taxes associated with the costs
 - c) A debit entry to record the transfer of amounts to or from other accounts as approved by the Commission, and
 - d) An entry equal to the interest on the average of the balance in this account at the beginning of the month and the balance in this account after the above entries at a rate equal to one-twelfth the interest rate on three month Commercial paper for the previous month, as reported in the Federal Reserve Statistical Release, H.15, or its successor.
