Purpose

As directed in Affiliate Rule IV.C.2, (Decision 97-12-088), Pacific Gas and Electric Company (PG&E) hereby submits its semi-annual update of its lists of service providers. The lists contain third party entities who are not affiliated with PG&E. PG&E requests authorization to continue to offer the following lists to its customers. The most recent lists were filed on May 6, 2006 in Advice Letter 2726-G/2823-E.
