Dr. Timothy Auran – current term concludes May 2023

Dr. Timothy Auran is an interventional radiologist at Radiology Associates in San Luis Obispo, with an interest in radiation therapy and the nuclear industry. He grew up outside of Cleveland, Ohio, received a bachelor's degree in Mechanical Engineering and interned at Westinghouse Electric working on the design of naval nuclear reactors. Dr. Auran attended medical school at Case Western Reserve University and completed his training in Radiology at Harbor-UCLA and UC San Diego.

Dr. Auran has lived on the Central Coast for 11 years and currently lives in the Squire Canyon area of Avila Beach. He has served in several medical staff positions at local hospitals, including Chief of Staff at Sierra Vista Regional Medical Center, and is currently CEO of Radiology Associates. Given his proximity to Diablo Canyon Power Plant and love of local hiking, he hopes to preserve the natural beauty of the area during and after the decommissioning process.

Dena Bellman – current term concludes May 2021

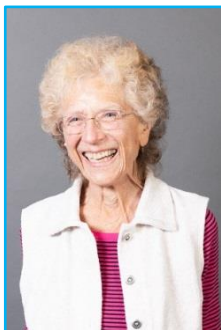

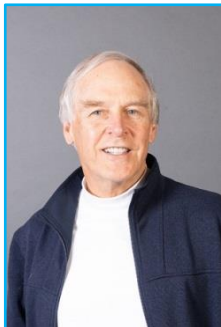
Lauren Brown – current term concludes May 2022

Lauren served in the American Peace Corps in India and obtained a Ph.D. in Organic Chemistry from the University of California, Riverside, when he returned. He co-founded JBL Scientific, a specialty biochemical company and moved to San Luis Obispo in 1973. In 1999 JBL Scientific was acquired by biotech company, Promega, and Lauren served as President of renamed Promega Biosciences until 2006, and subsequently served as President of another Promega subsidiary until 2008. In the community, Lauren has served on the YMCA Board, Chamber of Commerce Board, Chamber Economic Vision Task Force in 1992, the City of San Luis Obispo Economic Stability Task Force in 1993, as well as the Targeted Industries Task Force in 1997.
