**Public Workshops on Possible Future Uses of Diablo Canyon Lands and Facilities  
Announced**

**AVILA BEACH, Calif.** – During the months of August and September, the Diablo Canyon Decommissioning Engagement Panel will offer four public workshops to gather public input on the potential future uses of Diablo Canyon lands and facilities. The input offered by the public and the panel will be evaluated by PG&E as plans are developed for the plant's future decommissioning.
