Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Surf Tap 115 kV Power Line Relocation Project in the County of Santa Barbara and the City of Lompoc

Pacific Gas and Electric Company (“PG&E” or “the Company”) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

In order to accommodate a Santa Barbara County bridge replacement project, Pacific Gas and Electric Company (PG&E) has been requested to relocate approximately 1,700 feet of the existing Surf Tap 115 kilovolt (kV) Power Line in Santa Barbara County and the City of Lompoc. The current alignment of the power line parallels the western side of Floradale Avenue between W. Central Avenue and the Floradale Avenue Bridge, which spans the Santa Ynez River. Approximately 800 feet south of the intersection of Floradale Avenue (Santa Lucia Canyon Road) and Rancho Lompoc Farm Road, the current alignment of the power line turns eastward, crossing over Floradale Avenue. The power line segment to be relocated would cross over Floradale Avenue approximately 1,350 feet south of the intersection of Floradale Avenue (Santa Lucia Canyon Road) and Rancho Lompoc Farm Road. The power line would then continue north along the eastern side of Floradale Avenue for approximately 900 feet where it would meet the current power line alignment, which continues eastward. To accommodate this relocation, PG&E proposes to remove three existing wood poles and install three new wood or light-duty-steel poles in the new alignment. The existing poles are approximately 60 to 70 feet tall; the proposed poles will be approximately the same height or up to 15 feet taller. The taller poles are needed to comply with California Public Utilities Commission (CPUC) General Order 95 minimum

clearance requirements, and to meet current design standards. Construction is tentatively scheduled to begin in July 2019 or as soon as project plans and approvals are in place. Construction will be completed in December 2019, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts a utility from the CPUC's requirement to file an application requesting authority to construct if a project meets specific conditions. This project qualifies for the following exemption:

f. "power lines or substations to be relocated or constructed which have undergone environmental review pursuant to CEQA as part of a larger project, and for which the final CEQA document (Environmental Impact Report (EIR) or Negative Declaration) finds no significant unavoidable environmental impacts caused by the proposed line or substation."

The County of Santa Barbara adopted the Mitigated Negative Declaration for the Floradale Avenue Bridge 51C-006 Replacement Project, County Project Number 862032 on December 4, 2018, finding no significant unavoidable environmental impacts resulting from PG&E's proposed facilities. (State Clearinghouse # 2018081045.) The California Department of Transportation adopted a Categorical Exclusion for the same Floradale Avenue Bridge 51C-006 Replacement Project on May 6, 2015 (E.A. Project No, 05-0000-0863).

This submittal will not increase any rate or charge, cause the withdrawal of service, or conflict with any other rate schedule or rule.
