Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Eagle Rock-Redbud 115kV and Eagle Rock-Cortina 115kV Power Line Switch Replacements in the City of Clearlake, County of Lake

Pacific Gas and Electric Company (“PG&E” or “the Company”) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To maintain safe and reliable electric service in the City of Clearlake, PG&E is proposing to remove three wood poles with manually operated transmission switches, and replace these facilities with three larger, steel poles with Supervisory Control and Data Acquisition switches. Two of the three replacements will occur on the Eagle Rock-Redbud 115kV transmission line, and one replacement will occur on the Eagle Rock-Cortina 115kV transmission line. Work locations are 200 feet south of 16th Avenue (east of Boyles Avenue), between 21st and 22nd Avenue (just west of Konocti Avenue), and immediately north of 31st Avenue (just east Konocti Avenue) in the City of Clearlake. The work will improve operation and safety of the transmission lines. The steel poles will be approximately between 14 and 25 feet taller than the wood poles being replaced. Construction is tentatively scheduled to begin in late fall of 2019 or as soon as practicable after project approval. Construction will be completed in November of 2019, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

g. "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

This filing will not cause the withdrawal of service, or conflict with any other rate schedule or rule.

- g. Power lines or substations to be located in an existing franchise, road-widening setback easement or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by a federal, state or local agency for which the applicable CEQA document found no significant unavoidable environmental impacts.

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
