Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Stockton A#1 60kV Power Line SCADA Switch Replacement Project in the City of Stockton, County of San Joaquin

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To maintain safe and reliable electric service in the City of Stockton, Pacific Gas and Electric Company (PG&E) is proposing to remove two existing manually-operated transmission switches and replace the existing switches with two new Supervisory Control and Data Acquisition (SCADA) switches. PG&E will inter-set two new weathered steel engineered direct embedded poles (EDEPs) approximately 63 to 67 feet tall and convert one existing wood transmission pole to a distribution pole (reducing the height approximately 20 feet), all on the existing Stockton A#1 60 kilovolt (kV) Power Line in the City of Stockton. One new EDEP will be located within an existing PG&E easement approximately 425 feet southwest of the intersection of North Ryde Avenue with Mount Diablo Avenue, and the second EDEP will be located within the roadway (franchise) on the west side of North Ryde Avenue approximately 90 feet north of Louis Court. The two new EDEPs will be located within the existing power line alignment. Construction is tentatively scheduled to begin in December of 2019, or as soon as practicable after project approval. Construction will be completed in February of 2020, or as soon as possible after construction begins.

California Public Utilities Commission (CPUC) General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- g. "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

This submittal will not cause the withdrawal of service, or conflict with any other rate schedule or rule.

Protests

"power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

- a. There is reasonable possibility that the activity may have an impact on an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies; or
- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

- 1. Your name, mailing address and daytime telephone number.
- 2. Reference to the CPUC Advice Letter Number and Project Name.
- 3. A clear description of the reason for the protest.
- 4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
