**Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of Stockton A-Weber #3 60 kV Power Line SCADA Switch Replacement Project in the City of Stockton, County of San Joaquin**

Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

### **Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

### **Background**

To maintain safe and reliable electric service in the City of Stockton, PG&E is proposing to shorten one existing wood pole and replace two existing manually-operated switches with one new approximately 86-foot-tall engineered direct embedded pole with two Supervisory Control and Data Acquisition (SCADA) switches on the Stockton A-Weber #3 60 Kilovolt (kV) Power Line. The new engineered direct embedded pole will be approximately 9 feet taller than the existing wood pole to be shortened and will be located on the southerly side of East Fremont Street on the PG&E property known as East Stockton Substation, approximately 1,500 feet east of Wizard Avenue in the City of Stockton. Adjacent spans of conductor will be located in existing PG&E easements (existing easement). The work will improve the operation and safety of the power lines. Construction is tentatively scheduled to begin in April of 2020 or as soon as practicable after project approval. Construction will be completed in early May of 2020, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

g. "power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts."

This filing will not cause the withdrawal of service, or conflict with any other rate schedule or rule.

### **Protests**

- b. The cumulative impact of successive projects of the same type in the same place, over time, is significant; or
- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Protests should include the following:

1. Your name, mailing address and daytime telephone number.
2. Reference to the CPUC Advice Letter Number and Project Name.
3. A clear description of the reason for the protest.
4. Whether you believe that evidentiary hearings are necessary to resolve factual disputes.
