Purpose

Pursuant to General Order 96-B, General Rule 8.5.6 and Industry Rule 8.3, Pacific Gas and Electric Company (PG&E) is submitting this second supplemental Advice Letter submittal to change the request for approval of a settlement agreement between PG&E and the City of Oakland, a municipal corporation, acting by and through its Board of Port Commissioners (Port) regarding certain nonbypassable charges (Settlement) from a Tier 3 request to a Tier 2 request.

This second supplemental advice letter supplements the original Advice 5959-E and replaces the First Supplemental Advice 5959-E-A in its entirety.

PG&E submitted Advice 5959-E on September 22, 2020 as a Tier 3 advice letter. No party protested PG&E's submittal and the matter is still pending before the Commission. Upon further review, PG&E believes that a Tier 2 designation for Advice 5959-E is appropriate. Thus, PG&E is submitting the supplement to its advice letter requesting that this matter be designated as Tier 2 rather than Tier 3. The substance of Advice 5959-E, including requested approval for the Settlement, remains the same. The only thing changing with this supplement is the tier designation.
