Return of Unspent and Uncommitted Funds for Integrated Demand-Subject: Side Management

Purpose

The purpose of this advice letter is to propose the return of unspent and uncommitted funds to ratepayers for Integrated Demand-Side Management (IDSM) at the soonest available opportunity.1

Background

In D.12-04-045, the Commission stated that beyond 2012, all IDSM activities would be proposed and approved through the energy efficiency proceeding.² In the Commission's Decision Establishing Energy Efficiency Savings Goals and Approving 2015 Energy Efficiency Programs and Budgets, PG&E's existing energy efficiency program funding was extended annually through 2015 at the 2016 annual spending levels by program administrators as approved in that Decision until the earlier of 2025 or when the Commission issues a superseding decision on funding levels.³ Pursuant to Figure 6 of D.14-10-046, the CPUC approved an IDSM budget of \$3.264 million for 2015. The same amount was recovered in 2016.

On July 26, 2017, the Energy Division issued a disposition letter approving PG&E's 2017 EE Annual Budget Advice Letter 3753-G-A/B/C/D/4901-E-A/B/C/D which included a budget of \$3.264 million for IDSM.

Return of Unspent and Uncommitted Funds for IDSM Funding for Program Cycle 2015-2016 and 2017

PG&E proposes to return the unspent amount including interest⁴, which in total are estimated to be \$5.5 million for Program Cycle 2015-2016 and \$3.4 million for Program Cycle 2017⁵. Upon submittal of this advice letter, PG&E will transfer the unspent amount to the Distribution Revenue Adjustment Mechanism balancing account to be incorporated into rates through the next Annual Electric True-Up submittal.

The submittal would not increase any current rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.
