Subject: PG&E's 2021 Marketing & Outreach Plan for the Multi-Family Affordable Solar Housing (MASH) Program

Purpose

In compliance with Appendix A of Decision (D.) 08-10-036 and the subsequent Phase One Modification in D. 11-07-031 and D. 15-01-027 for MASH, Pacific Gas and Electric Company (PG&E) hereby requests the Energy Division's approval of its 2021 Marketing & Outreach Plan (M&O Plan) for the MASH programs in its service territory. As the MASH program sunsets and remaining applications proceed through the program, PG&E does not request an annual budget for MASH marketing and outreach.

Background

PG&E submits this 2021 M&O Plan in accordance with the above decisions and under the new process of separating the MASH M&O Plan from the California Solar Initiative (CSI) Plan in which it was previously filed.

2020 MASH Marketing and Outreach Plan:

As the MASH program was fully subscribed throughout 2020, there were no change to the existing MASH handbook or related training, and so no M&O budget was utilized in 2020.

2021 MASH Marketing and Outreach Plan:

Since the MASH program sunsets on December 31, 2021, and PG&E does not plan to open the MASH program to new applications due to that quickly approaching timeline, PG&E does not need and will not request an annual marketing and outreach budget for the MASH program for 2021.

PG&E intends this to be the final MASH M&O plan advice letter.
