Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To maintain safe and reliable electric service in Shasta County, Pacific Gas and Electric Company (PG&E) is proposing to re-tension conductor (wires), replace hardware, and replace approximately 12 wood poles on the existing Jessup Tap 115 Kilovolt (kV) Power Line in a rural residential area in unincorporated Shasta County, west of the City of Anderson, all within existing PG&E easement.

The Project begins at PG&E's Jessup Substation, located on the northeast side of Missouri Lane, approximately 725 feet southeast of the intersection of Missouri Lane with Spring Gulch Road. The alignment then runs in a southerly direction approximately 4,400 feet, crossing over Missouri Lane, an unnamed channelized stream, Fairwind Drive, the Anderson-Cottonwood Canal, and Aquado Avenue to an existing PG&E pole where the Jessup Tap 115kV Power Line joins PG&E's Trinity-Cottonwood 115kV Power Line, located approximately 1,225 feet west of the intersection of Aquado Avenue with Third Street. PG&E will replace 1 existing wood pole structure with 1 new tubular steel pole (approximately 20 feet taller) and replace approximately 11 existing wood pole structures with 11 new light duty steel pole structures (approximately 2 to 10

feet taller). Taller poles are required to comply with California Public Utilities Commission (CPUC) General Order 95 minimum ground-to-conductor clearance requirements. The existing line spans an unnamed channelized stream and the Anderson-Cottonwood Canal; however, no work will occur in stream channels or riparian habitat. Construction is tentatively scheduled to begin in August 2021 or as soon as practicable after project approval. Construction will be completed in October 2021, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental Impacts.

This submittal will not cause the withdrawal of service, or conflict with any other rate schedule or rule.
