**Subject: Submits Notice of Construction, Pursuant to General Order 131-D, for the Construction of the Oleum-North Tower-Christie 115kV Reconductor Project, County of Contra Costa**

Pacific Gas and Electric Company (“PG&E” or “the Company”) hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

**Purpose**

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

**Background**

To maintain safe and reliable electric service in Contra Costa County, Pacific Gas and Electric Company (PG&E) is proposing to replace conductor (wires), replace approximately 36 existing lattice steel tower structures with 29 new lattice steel tower structures and 7 new tubular steel pole structures, replace 1 existing 3-pole light duty steel pole (LDSP) structure with 1 new 3-pole LDSP structure (equivalent facilities), and remove 2 existing lattice steel tower structures on approximately 5.5 miles of the existing Oleum-North Tower-Christie 115 Kilovolt (kV) Power Line located within industrial and rural portions of unincorporated Contra Costa County.

The project begins at PG&E’s Oleum Substation (1150 San Pablo Avenue) in unincorporated Contra Costa County. The project alignment exits the substation and runs in a southeasterly direction approximately 1 mile through the Phillips 66 Refinery crossing Interstate Highway 80 where the power line enters rural open space and continues in a southeasterly and southerly direction approximately 3.4 miles traversing through rural open space, East Bay Regional Park District lands, crossing Cummings Skyway, 2 unnamed streams and State Route Highway 4; and then runs in a westerly

direction approximately 1.1 miles crossing Burlington Northern and Santa Fe Railroad and Christie Road, terminating at PG&E's Christie Substation (1033 Christie Road). The existing structures range in height from 74 feet to 109 feet tall. The new structure heights will be between 96 feet and 123 feet tall. Taller structures are needed to comply with California Public Utilities Commission (CPUC) General Order 95 minimum ground-to-conductor clearance requirements, while accommodating hilly terrain. The existing power line spans over 2 unnamed streams; however, no work will occur in the stream channels or riparian habitat. Helicopters will be used to facilitate construction and minimize ground disturbance at approximately 30 structures with constrained access. Construction is tentatively scheduled to begin in August 2021, or as soon as practicable after project approval. Construction is anticipated to be completed in the second quarter of 2023, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1 exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption(s),

b. "replacement of existing power line facilities or supporting structures with equivalent facilities or structures."

This submittal will not cause the withdrawal of service, or conflict with any other rate schedule or rule.
