Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To maintain safe and reliable electric service in the City of Rio Dell, Pacific Gas and Electric Company (PG&E) is proposing to replace approximately 0.3 miles of electric distribution conductor (wire) located beneath (underbuild) the existing Rio Dell Tap-60105B 60 Kilovolt (kV) Power Line conductor. PG&E will also replace approximately 5 existing wood poles with 5 new wood poles. The new wood poles will be approximately 1 to 15 feet taller than the existing wood poles. Taller poles are needed to comply with California Public Utilities Commission (CPUC) General Order 95 minimum ground-to-conductor clearance requirements, while accommodating electric distribution wires on the poles (underbuild).

The project begins at an existing wood pole located at the northeast corner of the intersection of Davis Street with Wildwood Avenue in the City of Rio Dell and runs east approximately 0.3 miles along the northerly boundary line of Davis Street (existing franchise) to an existing wood pole located at the northeast corner of the intersection of Davis Street with Ireland Street. Construction is tentatively scheduled to begin in October 2021, or as soon as practicable after project approval. Construction will be completed in December 2021, or as soon as possible after construction begins.

CPUC General Order 131-D, Section III, Subsection B.1, exempts projects meeting specific conditions from the CPUC's requirement to file an application requesting authority to construct. The Company believes this project qualifies for the following exemption,

- g. power line facilities or substations to be located in an existing franchise, road-widening setback easement, or public utility easement; or in a utility corridor designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies for which a final Negative Declaration or EIR [Environmental Impact Report] finds no significant unavoidable environmental impacts.

This submittal will not cause the withdrawal of service, or conflict with any other rate schedule or rule.
