Pacific Gas and Electric Company ("PG&E" or "the Company") hereby submits notice pursuant to General Order (G.O.) 131-D, Section XI, Subsection B.4, of the construction of facilities that are exempt from a Permit to Construct.

Purpose

This advice letter provides a copy of the Notice of Proposed Construction (Attachment I) and the Notice Distribution List, which comply with the noticing requirements found in G.O. 131-D, Section XI.

Background

To continue to maintain safe and reliable electric service in Kern County, PG&E is proposing to replace poles on the Wheeler Ridge - Tejon 70 kilovolt (kV) power lines (supporting structures) that extends approximately 5 miles between Wheeler Ridge Substation, located east side of Metter Frontage Road East and approximately 1,000 feet south of David Road in the Bakersfield area, and Tejon Substation, located east of the intersection of Interstate 5 and Highway 99 in Kern County. PG&E will replace approximately 80 poles on the Wheeler Ridge - Tejon 70 kV power line. The existing wood poles will be replaced primarily with wood poles except for three poles which will be replaced with light-duty steel poles, which weather to resemble wood. The new poles will be approximately 5 to 10 feet taller than the existing approximately 55- to 65-foot-tall poles. Construction is scheduled to begin in September 2022, or as soon as possible thereafter, with completion in May 2023, or as soon as possible after construction begins.

CPUC G.O. 131-D requires utilities to employ "no cost" and specified "low cost" measures to reduce public exposure to electric and magnetic fields (EMFs) in accordance with CPUC Decision 06-01-042 and the "EMF Guidelines for Electrical

Facilities” prepared in compliance with that decision. The following measure are proposed for this project:

- Raise the height of 1 pole near a residential land use area by 10 feet.

This submittal will not cause the withdrawal of service, or conflict with any other rate schedule or rule.

Exemption Under G.O. 131-D

CPUC G.O. 131-D, Section III, Subsection B.1 exempts a utility from the CPUC’s requirement to file an application requesting authority to construct if a project meets specific conditions. This project qualifies for the following exemption(s):

- b. “the replacement of existing power line facilities or supporting structures with equivalent facilities or structures.”

PG&E will replace approximately 80 poles on the Wheeler Ridge - Tejon 70 kV Power. The existing wood poles will be replaced primarily with wood poles except for three poles which will be replaced with light-duty steel poles, which weather to resemble wood. The new poles will be approximately 5 to 10 feet taller than the existing approximately 55- to 65-foot-tall poles.

None of the exceptions to the exemptions in Section III B.2, as specified in CEQA Guidelines section 15300.2, exist to disqualify this project from the NOC process.

The exceptions, and why they do not apply, include the following:

- a. There is a reasonable possibility that the activity may impact an environmental resource of hazardous or critical concern where designated, precisely mapped and officially adopted pursuant to law by federal, state, or local agencies.

Discussion: The project area does not contain critical habitat for endangered species or suitable aquatic habitat and/or potentially jurisdictional water resources or wetlands are not present. Additionally, there are no other designated, mapped and officially adopted resources of hazardous or critical concern which are known to occur in the project area.

- b. The cumulative impact of successive project of the same type in the same place, over time, is significant.

Discussion: PG&E is not aware of any other projects of the same type in the same place, or over time, that would result in significant cumulative impacts. Moreover, the proposed project would minimize the frequency of repairs and reduce the need for similar work within the electrical corridor in the future.

- c. There is a reasonable possibility that the activity will have a significant effect on the environment due to unusual circumstances.

Discussion: There is no reasonable possibility that the project will have a significant effect on the environment due to unusual circumstances.

PG&E is continually undertaking reconductoring and tower replacement projects throughout its territory, most of which require replacement, removal and/or addition of structures as well as replacement of the conductors. Numerous reconductoring and replacement projects have established staging areas, used cranes for construction, required vegetation removal or surface recontouring, and adjusted structure locations to avoid resources or other impacts. This project, however, does not include reconductoring. There is nothing about this project that is different from others in its class.

In addition, there is no evidence of a reasonable possibility of a significant impact. This project consists of replacing existing poles with similar facilities in a largely agricultural area. The construction and operation would not result in any potentially significant impacts. The project has been designed to avoid impacts to biological resources, and no other potential impacts have been identified that would result in a significant effect on the environment due to unusual circumstances.

The Company requests that this Tier 2 advice letter become effective on July 27, 2022, which is 30 days after the date of submittal. (In accordance with G.O. 131-D, construction will not begin until 45 days after notice is first published.)
