Subject: Report in Compliance with Ordering Paragraph 1 of Decision 21-10-020

Purpose

This submittal provides information required by Ordering Paragraph (OP) 1 of Decision (D.) 21-10-020 regarding Pacific Gas and Electric Company's (PG&E) restoration, rebuilding, and reconstruction activities related to the Alisal and Colorado Fires.

Background

OP 1 of D.21-10-020 requires that:

In the event of a disaster, declared either by the Governor of California or the President of the United States, that also damages their facilities or leads to a service outage, Investor-Owned Utilities (IOUs) shall file a Tier 1 Advice Letter within 15 business days from when they are allowed into a disaster area to assess the damage to their facilities. IOUs shall file this Advice Letter with the Commission's Energy Division, with a copy sent to the Communications Division at TD._PAL@cpuc.ca.gov. The Advice Letter also must be provided to the appropriate local government contained within the disaster area, including the chief executive or leader of the city, township or Tribal government. In the case of an unincorporated area, the communication must be established with the appropriate County. In the case of Tribal governments, the Advice Letter must be provided to any Tribe(s) that have Tribal lands or ancestral territory overlapping with any portion of the disaster area. The Advice Letter shall include the following details:

- a. a report of what facilities or equipment was damaged.
- b. restoration and/or rebuild plans, including a description of what is being repaired, replaced, or added, and maps of where the restoration will occur.
- c. the date the investor-owned utility received access to the damaged area.
- d. the timeline to make repairs.
- e. any changes to any energy/communication infrastructure required; and

- f. the contact information of the individual responsible for community engagement in these instances.

On July 1, 2022, Governor Newsom proclaimed a State of Emergency in the counties of Santa Barbara and Monterey due to the Colorado Fire. On October 11, 2021, the Alisal Fire began burning in Santa Barbara County and on January 21, 2022, the Colorado Fire began burning in Monterey County and burned for nearly two weeks. The information required by OP 1 is as follows:

- 1) Facilities / equipment damaged: No facilities or equipment were damaged in these declared disaster areas.
- 2) Restoration / Rebuild Plans – No restoration or rebuild will be required.
- 3) Date received access to damaged areas – No access impaired as no restoration or rebuild will be required.
- 4) Timeline to make repairs – Not applicable.
- 5) Changes to infrastructure – Not applicable.
- 6) Contact information of community engagement – Not applicable.

Because there was no service restoration effort requiring action, PG&E did not engage with community stakeholders as contemplated by OP 2 of D.21-10-020. Accordingly, PG&E will not be submitting a second Advice letter as contemplated in OP 3.

Tariff Revisions

This submittal does not require any tariff revisions and would not increase any current rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

The protest shall contain the following information: specification of the advice letter protested; grounds for the protest; supporting factual information or legal argument; name and e-mail address of the protestant; and statement that the protest was sent to the utility no later than the day on which the protest was submitted to the reviewing Industry Division (General Order 96-B, Section 3.11).

Pursuant to General Order (GO) 96-B, Rule 5.1, this advice letter is submitted with a Tier 1 designation. PG&E requests that this Tier 1 advice submittal become effective on regular notice, August 19, 2022, which is 30 calendar days after the date of submittal.
