Subject: Report in Compliance with Ordering Paragraph 1 of Decision 21-10-020

Purpose

This submittal provides information required by Ordering Paragraph (OP) 1 of Decision (D.) 21-10-020 regarding Pacific Gas and Electric Company's (PG&E) restoration, rebuilding, and reconstruction activities related to the Mosquito Fire and Fairview Fire.

Background

OP 1 of D.21-10-020 requires that:

In the event of a disaster, declared either by the Governor of California or the President of the United States, that also damages their facilities or leads to a service outage, Investor-Owned Utilities (IOUs) shall file a Tier 1 Advice Letter within 15 business days from when they are allowed into a disaster area to assess the damage to their facilities. IOUs shall file this Advice Letter with the Commission's Energy Division, with a copy sent to the Communications Division at TD._PAL@cpuc.ca.gov. The Advice Letter also must be provided to the appropriate local government contained within the disaster area, including the chief executive or leader of the city, township or Tribal government. In the case of an unincorporated area, the communication must be established with the appropriate County. In the case of Tribal governments, the Advice Letter must be provided to any Tribe(s) that have Tribal lands or ancestral territory overlapping with any portion of the disaster area. The Advice Letter shall include the following details:

- a. a report of what facilities or equipment was damaged.
- b. restoration and/or rebuild plans, including a description of what is being repaired, replaced, or added, and maps of where the restoration will occur.
- c. the date the investor-owned utility received access to the damaged area.
- d. the timeline to make repairs.
- e. any changes to any energy/communication infrastructure required; and

- f. the contact information of the individual responsible for community engagement in these instances.

On September 8, 2022, Governor Newsom proclaimed a State of Emergency in the counties of El Dorado and Placer due to the Mosquito Fire and Riverside County due to the Fairview Fire. On September 6, 2022, the Mosquito Fire began burning in Placer County and has burned into El Dorado County and more than 76,290 acres and continues to burn with 49% contained as of September 21, 2022. (Fairview Fire is outside of PG&E Service Territory and will not be addressed by PG&E). The information required by OP 1 is as follows:

- 1) Facilities / equipment damaged – The table below indicates PG&E’s damaged equipment as of September 21, 2022, from the Mosquito Fire.

- 2) Restoration / Rebuild Plans – PG&E’s plans for the Mosquito Fire include service restoration and replacement of equipment on a like-for-like basis and system hardening in approximately five locations.
- 3) Date received access to damaged areas – For the Mosquito Fire, PG&E received access into Michigan Bluff on September 10, 2022, Foresthill proper on September 13, 2022, and Volcanoville September 14, 2022.
- 4) Timeline to make repairs – PG&E completed repairs resulting from the Mosquito Fire on September 18, 2022.
- 5) Changes to infrastructure – There are no changes to PG&E infrastructure for the Mosquito Fire.
- 6) Contact information of community engagement – PG&E participated in Virtual Meetings hosted by Incident Management Team in Roseville. These meeting were with local public information offices and elected officials for El Dorado and Placer Counties.

Tariff Revisions

This submittal does not require any tariff revisions and would not increase any current rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

Pursuant to General Order (GO) 96-B, Rule 5.1, this advice letter is submitted with a Tier 1 designation. PG&E requests that this Tier 1 advice submittal become effective on regular notice, October 29, 2022, which is 30 calendar days after the date of submittal.
