Subject: Report in Compliance with Ordering Paragraph 1 of Decision 21-10-020

Purpose

This submittal provides information required by Ordering Paragraph (OP) 1 of Decision (D.) 21-10-020 regarding Pacific Gas and Electric Company's (PG&E) restoration, rebuilding, and reconstruction activities related to the Fork Fire.

Background

OP 1 of D.21-10-020 requires that:

In the event of a disaster, declared either by the Governor of California or the President of the United States, that also damages their facilities or leads to a service outage, Investor-Owned Utilities (IOUs) shall file a Tier 1 Advice Letter within 15 business days from when they are allowed into a disaster area to assess the damage to their facilities. IOUs shall file this Advice Letter with the Commission's Energy Division, with a copy sent to the Communications Division at TD._PAL@cpuc.ca.gov. The Advice Letter also must be provided to the appropriate local government contained within the disaster area, including the chief executive or leader of the city, township or Tribal government. In the case of an unincorporated area, the communication must be established with the appropriate County. In the case of Tribal governments, the Advice Letter must be provided to any Tribe(s) that have Tribal lands or ancestral territory overlapping with any portion of the disaster area.

The Advice Letter shall include the following details:

- a. a report of what facilities or equipment was damaged;
- b. restoration and/or rebuild plans, including a description of what is being repaired, replaced, or added, and maps of where the restoration will occur;
- c. the date the investor-owned utility received access to the damaged area;
- d. the timeline to make repairs;

- e. any changes to any energy/communication infrastructure required; and
- f. the contact information of the individual responsible for community engagement in these instances.

On September 19, 2022, Governor Newsom proclaimed a State of Emergency in the county of Madera County due to the Fork Fire, Modoc County due to the Barnes Fire, and Siskiyou County due to the Mountain Fire. The Mountain Fire began burning in Siskiyou County on September 2, 2022, and has since burned more than 13,440 acres. The Barnes Fire began burning in Modoc County on September 7, 2022, and continues to threaten homes. The Fork Fire began to burn in Madera County and has burned 819 acres. The information required by OP 1 is as follows:

- 1) Facilities / equipment damaged – The table below indicates PG&E's damaged equipment as of September 20, 2022, related to the Fork Fire.

No PG&E facilities or equipment were damaged in the Barnes and Mountain Fire disaster areas.

- 2) Restoration / Rebuild Plans – PG&E's plans for the Fork Fire included service restoration and replacement of equipment on a like-for-like basis. No PG&E equipment restoration or rebuild is necessary due to the Barnes and Mountain Fires.
- 3) Date received access to damaged areas – PG&E received access to the Fork Fire disaster area on September 8, 2022. PG&E did not face impaired access to the damaged areas due to from the Barnes and Mountain Fires, because there was no need to perform restoration or rebuilding.
- 4) Timeline to make repairs – PG&E completed repairs related to the Fork Fire on September 12, 2022. No repairs were required due to the Barnes and Mountain Fires.
- 5) Changes to infrastructure – There are no changes to PG&E infrastructure for any of the fires, given the previously described restoration and rebuild plans for the fires.
- 6) Contact information of community engagement – PG&E's performed community engagement activities for the Fork Fire with the following public safety agency partners: CAL FIRE, US Forest Service, Madera County Fire Department, California Highway Patrol, Madera County Sheriff's Office and California Office of Emergency Services. PG&E also provided updates to the North Fork Rancheria of Mono Indians through their agency representative. No community engagement was necessary for the Barnes and Mountain Fires.

Tariff Revisions

This submittal does not require any tariff revisions and would not increase any current rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.

The protest shall contain the following information: specification of the advice letter protested; grounds for the protest; supporting factual information or legal argument; name and e-mail address of the protestant; and statement that the protest was sent to the utility no later than the day on which the protest was submitted to the reviewing Industry Division (General Order 96-B, Section 3.11).

Pursuant to General Order (GO) 96-B, Rule 5.1, this advice letter is submitted with a Tier 1 designation. PG&E requests that this Tier 1 advice submittal become effective on regular notice, November 4, 2022, which is 30 calendar days after the date of submittal.
