Subject: Submission of Pacific Gas and Electric's (PG&E) E-ELEC Electric Rate to be added as a Self-Generation Incentive Program Approved Rate

Purpose

Pursuant to Ordering Paragraph (OP) 3A. of Decision (D.)19-08-001 Pacific Gas & Electric Company (PG&E) submits this advice letter (AL) to add PG&E's E-ELEC electric rate to the list of SGIP-approved rates.

Background

On August 9, 2019, the Commission issued D.19-08-001 establishing greenhouse gas emission (GHG) requirements for the Self-Generation Incentive Program (SGIP) storage budget and requiring new SGIP residential projects to be on a time varying rate with a 1.69 or greater differential between summer peak and off-peak period, and a peak period starting at or after 4 pm, if such a rate is available to the customer. OP 3A. of the decision requires a Program Administrator to file "one or more Tier 2 advice letters describing time-varying rates" that meet these requirements to be approved as meeting upfront eligibility requirements for new residential customers. PG&E files this advice letter in accordance with this requirement.


PG&E's E-ELEC Rate

PG&E has identified PG&E's E-ELEC electric rate as meeting the requirements of D.19-08-001 OP 3A. E-ELEC has a 1.7 off-peak to on-peak differential, and an on-peak time starting at 4 pm¹.

Table 1 below summarizes the qualifications of the E-ELEC rate.

Therefore E-ELEC should be incorporated into PG&E's list of SGIP-approved rates.
