Subject: March 1, 2020 Gas Core Procurement and Transportation Rate Tariff Changes

Pacific Gas and Electric Company ("PG&E") hereby submits for submittal, revisions to its gas tariffs. The affected tariff sheets are included in Attachment 1 to this submittal.

Purpose

The purpose of this submittal is to submit changes to PG&E's core end-use customer gas rates effective March 1, 2020. Specifically, this submittal revises PG&E's gas procurement rates for core customers.

This submittal is submitted in compliance with D. 97-10-065, which approved monthly changes for gas procurement rates for core customers. Consistent with D. 98-07-025, PG&E's core procurement rates changes are made effective no later than the fifth business day of the month.¹

In addition, this advice letter incorporates changes to core transportation rates consistent with those being submitted in PG&E's Noncore Advice Letter 4223-G, which incorporates rate revisions for revenue requirement allocation changes approved by the California Public Utilities Commission (CPUC) effective March 1, 2020². The Noncore advice letter consolidates CPUC approved rate changes implementing Decision (D.) 19-10-036 (PG&E's 2018 Gas Cost Allocation Proceeding) and Resolution G-3565. The overall allocative effect of the consolidated rate changes across core and noncore transportation rates is an increase in core gas revenues of approximately \$3.9 million³

on an annualized basis. Noncore transportation rates are decreasing by \$1.9 million on an annualized basis.

Procurement Rate Changes

PG&E is revising the gas procurement charges shown on core end-use customer Schedules G-1, G1-NGV, GM, GS, GT, GL-1, GL1-NGV, GML, GSL, GTL, G-NR1, G-NR2, G-NGV1, G-NGV2 and G-CP—*Gas Procurement Service to Core End-Use Customers*. The procurement charges shown on Schedule G-CP are for illustrative purposes only and are the same as those shown on the end-use customer schedules. The gas procurement rate varies by rate schedule due to the allocation of capacity charges to the core customer classes.

Schedule G-CP procurement charges proposed in this submittal are shown below:

The Schedule G-CP rates effective March 1, 2020 reflect:

1. A monthly weighted average cost of gas ("WACOG") of \$0.17267 per therm, compared to last month's WACOG of \$0.21544 per therm;
2. A credit of \$0.00471 per therm to amortize over 1 month a \$970 thousand over-collection in the Core Sales subaccount of the Purchased Gas Account ("PGA");
3. A charge of \$0.00498 per therm to amortize over 1 month a \$1.0 million under-collection in the Core Shrinkage subaccount of the PGA;
4. A credit of \$0.00604 per therm to amortize over 12 months a \$13.0 million over-collection in the Core Firm Storage Account;
5. A credit of \$0.00372 per therm to amortize over 12 months a \$8.0 million over-collection in the Core Pipeline Demand Charge Account; and
6. A charge of \$0.01630 per therm to recover costs associated with PG&E's winter hedging program, recorded in the Core Gas Hedging Plan subaccount of the Purchased Gas Account.

In accordance with D. 97-10-065 and D. 98-07-025, PG&E requests that this advice submittal be approved effective March 1, 2020.

The master-meter/submeter rate discount provided herein prohibits further recovery by mobilehome park owners for the costs of owning, operating and maintaining their gas submetered system. This prohibition also includes the cost of the replacement of the submetered gas system. This provision was authorized in Ordering Paragraph 4 of CPUC Decision 95-02-090, dated February 22, 1995.

APPLICABILITY: This rate schedule¹ applies to natural gas service to Core End-Use Customers on PG&E's Transmission and Distribution systems. To qualify, service must be master-metered for residential use in a mobilehome park multifamily accommodation through one meter on a single premises and submetered to all individual tenants in accordance with Rule 18 where one or more of the submetered tenants qualifies for California Alternate Rates for Energy (CARE) under the eligibility and certification criteria set forth in Rules 19.1, 19.2 or 19.3. This schedule is closed to new mobilehome parks and manufactured housing communities for which construction commenced after January 1, 1997.

Per D.15-10-032 and D.18-03-017, transportation rates include GHG Compliance Cost for non-covered entities. Customers who are directly billed by the Air Resources Board (ARB), i.e., covered entities, are exempt from paying AB 32 GHG Compliance Costs through PG&E's rates.² A "Cap-and-Trade Cost Exemption" credit for these costs will be shown as a line item on exempt customers' bills.^{3, 4}

TERRITORY: Schedule GTL applies everywhere within PG&E's natural gas Service Territory.

RATES: Customers on this schedule pay a Procurement Charge and a Transportation Charge, per meter. Qualifying CARE Core End-Use Customers receive a CARE Discount, which applies to both procurement and transportation charges.
