Subject: Add the San Francisco Marina Safeway Property to the Hazardous Substance Mechanism

Purpose

Pacific Gas and Electric (PG&E) hereby requests California Public Utilities Commission (CPUC) approval to include the San Francisco Marina Safeway Property in the Hazardous Substance Cost Recovery Account, in compliance with Decision (D.) 94-05-020.

Background

D.94-05-020 requires California utilities to file an advice letter in order to include additional sites as part of the Hazardous Substance Mechanism. For each site the advice letter shall list: 1) the name of the site(s); 2) the location of the site(s); 3) the source, nature and approximate date of the contamination; 4) utility operations (historical and current) at the site(s), if any; and 5) environmental agency actions and oversight regarding the site(s), if any.

In addition, D. 96-07-016 requires utilities to demonstrate that: 1) clean-up costs for which recovery is being sought are not being recovered through base rates or through any other recovery procedure, and 2) all of the costs for which recovery is being sought are hazardous waste clean-up costs (including insurance costs) found appropriate for recovery in the Hazardous Substance Cleanup Cost Recovery Collaborative Report.

Site Information

Site Name:

San Francisco Marina Safeway Property.

Site Location:

The Safeway property is located at 15 Marina Boulevard (assessor's parcel number 0446002), San Francisco, California.

Source, Nature, and Approximate Date of Contamination:

The Sierra and San Francisco Power Company constructed an electric generation plant adjacent to the San Francisco Gas and Electric North Beach MGP in 1903. After 1920, this plant was leased by PG&E and operated as a de facto part of the PG&E system. PG&E acquired Sierra and San Francisco Power Company outright in 1927. The plant, damaged in the 1906 earthquake, was back in service in May 1906 and operated through March 1942.

The power plant used oil to generate electricity. Oil was delivered to the steam-electric plant via pipeline from the nearby wharf on San Francisco Bay and stored in a 30,000 gallon above ground storage tank at the southeast corner of the property. Two small crude oil tanks were located in the center of the block. The plant went through various modifications between 1928 and 1940.

A Safeway store was built on the property in 1959 and remains in business. Geotechnical investigations conducted in 1958 and 1995 by third parties for Safeway reported a chemical odor, carbonaceous materials and oily material in two borings.

Utility Operations at the Site:

PG&E operated the plant beginning in 1920 through March 1942, when the plant was retired and abandoned in place. After sitting unused for over a decade, the plant was dismantled in 1956.

Environmental Agency Actions:

There is currently no agency involvement with this property. The San Francisco Regional Water Quality Control Board has verbally contacted PG&E and intends to request investigation of the property pursuant to Water Code Section 13267 based on historical use.

Nature of Costs:

The site cleanup costs for which PG&E is seeking HSM recovery are not being recovered in base rates or through any other recovery procedure. Cleanup costs to be recorded by PG&E in the HSM memorandum accounts will be hazardous substance cleanup costs found appropriate for recovery in the Hazardous Substance Cleanup Cost Recovery Collaborative Report.
