Purpose

Pursuant to Decision (D.) 22-02-025 (“Decision”) Implementing Senate Bill (SB) 1440 Biomethane Procurement Program, Ordering Paragraph (“OP”) 36, Pacific Gas and Electric Company (“PG&E”), Southern California Gas Company (“SoCalGas”), San Diego Gas and Electric Company (“SDG&E”), and Southwest Gas Corporation (“SWG”) (collectively, the “Joint Utilities”) submit this Tier 1 Advice Letter to update the Biomethane Incentive Reservation form.

Background

On December 5, 2019, the California Public Utilities Commission (CPUC) approved D.19-12-009 Establishing a Reservation System for the Biomethane Incentive Program, Extending Date and Addressing Rate Recovery for Pipeline Interconnection Infrastructure. This decision implemented an Incentive Reservation System for the biomethane monetary incentive program initially established pursuant to D.15-06-029. The biomethane monetary incentive program provides up to \$3 million for non-dairy cluster projects and \$5 million for dairy clusters that successfully interconnect with the natural gas pipeline system and operate by December 31, 2026. The Biomethane Incentive Reservation System allows project developers to reserve incentive funds during the development phase of a project and receive the funds once the project is interconnected and operating in accordance with utility tariffs. Applications for the

Incentive Reservation System are designed to ensure that only viable projects can secure a spot on the reservation and waiting lists managed by the CPUC's Energy Division.

On December 19, 2019, the Joint Utilities filed their respective advice letters developing a standard Biomethane Incentive Reservation form that meets the criteria outlined in Section 3.2 and 3.3 of D.19-12-009. These advice letters were approved with an effective date of December 19, 2019.¹

On February 24, 2022, the CPUC approved D.22-02-025. This decision implements SB 1440 by setting biomethane (renewable natural gas (RNG) and/or bio-synthetic natural gas (bio-SNG)) procurement targets for the gas utilities' core customers to reduce short-lived climate pollutant emissions and adopts provisions to achieve additional co-benefits and timetables for each investor-owned utility providing gas service in California. This decision also requires, among other items, the following as indicated in OP 36:

Within 30 days of the effective date of this decision, Southern California Gas Company, Pacific Gas and Electric Company, San Diego Gas & Electric Company, and Southwest Gas Corporation shall each file a Tier 1 Advice Letter updating the Biomethane Incentive Reservation Form to include an agreement to limit hydrogen sulfide in gathering lines to 10 parts per million.

In accordance with OP 36, the Joint Utilities collaborated to revise the established standard Biomethane Incentive Reservation form for biomethane producers seeking a monetary incentive to acknowledge this new requirement (Attachment A). Further the Joint Utilities collaborated to develop a Biomethane Incentive Reservation supplemental form intended for biomethane producers who are already on the waitlist to receive a monetary incentive to acknowledge and comply with this new requirement (Attachment B).

Once the Joint Utilities' Tier 1 advice letters are approved by the Energy Division, the updated standard Biomethane Incentive Reservation forms will be made available for download on each utility's website.

Tariff Revisions

The submittal would not increase any current rate or charge, cause the withdrawal of service, or conflict with any rate schedule or rule.
