Subject: Annual Update regarding Pacific Gas and Electric Company's Climate Vulnerability Assessment

Purpose

In accordance with Decision 20-08-046 (the "Decision"), Ordering Paragraph 13, Pacific Gas and Electric Company ("PG&E") hereby provides an annual update regarding progress on PG&E's Climate Vulnerability Assessment ("CVA").

Decision 20-08-046, Ordering Paragraph 13 requires:

"The IOUs shall annually, at the end of the first quarter of each calendar year, file and serve on the service list of this proceeding (or a successor proceeding) a Tier 1 Advice letter with the Commission's Energy Division listing the individuals with their departments on the IOU's climate change team and the name of the senior level executive to whom the climate change team directly reports. The annual Tier 1 Advice letter shall include a status update that describes the activities of the climate change team in the last year and anticipated upcoming milestones that will lead up to the next vulnerability assessment filing."

Background

On August 27th, 2020 the CPUC issued D. 20-08-046 on Energy Utility Climate Change Vulnerability Assessments and Climate Adaptation in Disadvantaged Communities. In Ordering Paragraph 13 of the Decision, the CPUC requires the IOUs to submit an annual advice letter at the end of the first quarter of each calendar year (1) "listing the individuals and departments of the IOU's climate change team and the name of the senior level executive to whom the climate change team reports" and (2) "include a status update that describes the activities of the climate change team in the last year and anticipated upcoming milestones that will lead up to the next vulnerability assessment filing."

Information Regarding PG&E's Climate Change Team

As part of PG&E's commitment to embed climate resilience and safety across all lines of business, the Climate Resilience Team moved from Corporate Affairs to the Engineering, Planning, and Strategy (EP&S) department in September of 2021. This transition consolidates PG&E's climate resilience activities and actions resulting from the CVA under one executive sponsor, Jason Glickman, to ensure involvement of executive leadership and a consistent owner for cross-team collaboration. The specific daily program activities of PG&E's climate resilience team are overseen by the Senior Director of System and Resource Planning, Harsh Grover and Senior Manager for Climate Resilience, Nathan Bengtsson. PG&E's LEAN operating system allows for daily updates to the Senior Vice President level if necessary.

As of this filing, the following employees represent PG&E's core Climate Change Team, comprised of senior level executives, responsible managers, and primary Climate Resilience Team staff:

Information regarding PG&E's Climate Vulnerability Assessment

In 2021 and Q1 2022, PG&E's Climate Resilience Team completed the following activities to advance the Climate Vulnerability Assessment:

- PG&E continued to execute CVA activities across the entire service territory. Initially the technical elements of the CVA were organized in a region-by-region approach. However, the technical analysis approach transitioned to a territory-wide approach to streamline internal review processes and better align with management structures. The result is that PG&E will conclude baseline technical assessment activities sooner than originally planned, likely by mid-2023.

- PG&E maintains a regionalized approach to community engagement activities. This approach is most appropriate given the size of PG&E's service territory, the diversity of communities it serves, and PG&E's bankruptcy-related regionalization commitments.
- With support from long-time third-party partner ICF, PG&E's Climate Resilience Team completed the Region 1 ("San Francisco Bay Area") and is on track to complete the remainder of the CVA Technical Analyses across the entire service territory, using the definitions and data guidance from Decisions 19-10-054 and 20-08-046.
- PG&E coordinated review of both methodology and Region 1 results with the appropriate asset management SMEs from the gas, electric, and generation lines of business.
- With support from BluePoint Planning, PG&E's Climate Resilience Team planned and began conducting community engagement related to Region 1 CVA insights.
- The community engagement plan uses the *CPUC's Environmental and Social Justice Action Plan* and the *Disadvantaged Communities Advisory Group Equity Framework* as guides for engagement with disadvantaged vulnerable communities.

Going forward in 2022, PG&E expects to:

- Complete the remainder of the CVA Technical Analyses across the entire service territory, with support from ICF.
- Review the results with the appropriate asset management SMEs from the gas, electric, and generation lines of business.
- Complete initial community engagement activities related to Region 1 CVA
- Incorporate results of community engagement and recommended adaptation actions to finalize the Region 1 CVA Section
- Complete community engagement plans for Region 2 ("Inland South") and Region 3 ("Inland North")
- Begin conducting community engagement activities in Region 2.
