1.	(Applicant), has requested PACIFIC GAS AND ELECTRIC COMPANY, a California corporation (PG&E), to deliver Gas / Electric energy to the property situated at Enter Address Here and shown on the attached drawings.

- 2. Applicable Documents. The cost summary for the facilities to be installed is attached hereto as Exhibit A. These facilities shall be installed in accordance with the applicable rules on file with the California Public Utilities Commission (which may include Gas and Electric Rules 2, 13, 15, 16, and 20), as well as the requirements set forth in the Provisions (Form 62-0982) and the General Terms and Conditions for Gas and Electric Service by Applicant (Form 79-716) These documents are located online in PG&E's Tariff Book, which is available at http://www.pge.com/ Should you require hard copies please contact your PG&E Representative.
- 3. Construction Options. The responsibility for providing line extension work is divided between PG&E and the Applicant. However, Applicant may choose to have a qualified contractor perform some of the work that is PG&E's responsibility and may choose to have PG&E perform some or all of the work that is the Applicant's responsibility. Per Decision 22-09-026, Residential and Non-Residential Customers submitting an application for new gas service on or after July 1, 2023, do not qualify for Allowances, Refunds or Discount Option.¹ Per Decision 23-12-037, Mixed-Fuel New Constructions project applications received after July 1, 2024, will not qualify for Allowances, Refunds, or Discount Option.² For new applications for Gas Service Extension(s) on or after July 1, 2023, and Mixed Fuel New Construction projects after July 1, 2024, Applicants must pay PG&E its total estimated installed cost upon contract execution, in advance of PG&E commencing its work. Upon completion of the work and determination of actual costs, PG&E will provide Applicant with a final invoice or refund to account for a true-up to actual costs (excluding Betterment and Utility Convenience). For new applications for gas Distribution Main or Service Extension(s) submitted before July 1, 2023, and Electric Projects, PG&E will reimburse or collect money based on its estimate of the costs, (excluding Betterment and Utility Convenience), subject to the applicable rules. An Applicant's failure to pay a final invoice in a timely manner is a violation of PG&E's Gas Rules 15/16 and may result in discontinuance of service. Based on Applicant's request, the contract costs are based on the following construction options:
