

2. **DESCRIPTION OF SERVICE**

Detailed description of service is provided in Rule 2.

PROCEDURE TO OBTAIN SERVICE

Any person or corporation whose premises are adjacent to PG&E's distribution mains can obtain gas service from PG&E by making application in accordance with Rule 3, and, if required, by signing a contract in accordance with Rule 4. Applicants for service must conform to and comply with the applicable PG&E filed tariff schedules. Where an extension of PG&E's main or service piping is necessary or a substantial investment is required to supply service, the applicant will, upon application to PG&E, be informed as to the conditions under which service will be supplied.

ESTABLISHMENT OF CREDIT AND DEPOSITS

After making proper application for gas service, the applicant must establish credit with PG&E in accordance with Rule 6.

When credit is established by making a cash deposit, such deposit shall be made in accordance with Rule 7.

SAMPLE FORMS 5.

Sample copies of printed forms that are normally used in connection with customers' services such as applications for service, regular bills for service, contract forms, delinquency notices, disconnect notices, deposit receipts, and similar forms are considered a part of PG&E's tariffs schedules.

From time-to-time PG&E may present sample forms (agreements, applications, contracts and declarations) to the customer electronically on PGE.com web portal services and other presentation channels such as software applications and devices in various formats including, but not limited to, on-line downloadable forms, protected fillable forms, or as electronic forms (e-forms).

E-forms are based on current and effective terms and conditions of the approved form by the Commission, however, the presentment of the e-form could vary from the original form because only relevant information from the original form maybe presented on the e-form.

The e-form additionally could differ from the original filed agreement as the electronic presentment may offer affirmative ("opt-in") electronic or "click" signatures in place of a formal signature line. The e-form may contain additional information including but not limited to: privacy and security policy information; the web site's terms of use policy; links to other related documents or programs; affirmative checkbox(s); error and invalid entry notification; customer consent to electronically transmit information; captcha; multi-factor authentication; and instructional information specific to the e-form (e.g., click next to continue).

PG&E may prepare sample forms for electronic presentment and using automated procedures. Such documents may have a standardized appearance that differs from the originally-filed form; however, the form in-part or in-whole will contain functionality to present or reference the applicable terms and conditions of the original on file with and approved by the Commission and comply with all applicable customer privacy rules and standards. These documents shall be identified with the footnote; "Automated Document, Preliminary Statement, Part A."

GENERAL

- MEASUREMENT OF GAS: All gas as supplied by PG&E to its customers shall be measured by means of gas meters except as may otherwise be provided in PG&E's tariffs. If the installation of a gas meter is impractical, usage will be estimated from load and operating data
- b. DISCOUNTS: All rates hereinafter listed are net rates and are not subject to discount, unless specifically stated on the schedule.
- c. DISCOUNTS FOR ADVANCES BY CUSTOMERS: Unless otherwise specified in PG&E's tariffs, no discounts in rates are allowed in consideration of customers advancing funds.
- d. STANDARD RIDERS: No standard riders are used by PG&E.

7. SYMBOLS

When any change is proposed on any tariff schedule, attention shall be directed to such change by an appropriate character along the right-hand margin of the official copies filed with the Commission, utilizing the following symbols:

- (C) To signify changed listing, rule, or condition which may affect rates or charges;
- (D) To signify discontinued material, including listing, rate, rule or condition;
- (I) To signify increase;
- (L) To signify material relocated from or to another part of tariff schedules with no change in text, rate, rule or condition;
- (N) To signify new material including listing, rate, rule or condition;
- (P) To signify material subject to change under a pending application or advice letter;
- (R) To signify reduction; and
- (T) To signify change in wording of text but no change in rate, rule or condition.
