

Northern San Joaquin 230 kV Transmission Project

Pacific Gas & Electric Company (PG&E) is proposing a series of electrical upgrades in Northern San Joaquin County, known as the Northern San Joaquin 230 kV Transmission Project. This project was formerly called the Lockeford-Lodi Area 230 kV Development or Northern San Joaquin Power Connect. The proposed project will help us continue providing you with safe and reliable electric service.

Project status


We submitted a permit application for this proposed project to the California Public Utilities Commission (CPUC) in September 2023. The CPUC will conduct an environmental review and will review the project need and costs before making a decision on the proposed project.

What we are doing

- The project will connect an existing PG&E 230 kilovolt (kV) electrical line into our Lockeford Substation.
- We will also rearrange connected portions of our electric 60 kV system in the area.
- A new 230 kV electrical line will connect our Lockeford Substation to our new switching station in Lodi.
- The City of Lodi's Electric Utility will construct a new substation to connect to our new switching station.

Our work with the community

We are committed to keeping the community engaged. To help us identify potential transmission line routes, our team conducted several rounds of outreach. We also gathered information through desktop studies, field studies, and input from local governments and other agencies. With the project application submitted, CPUC is now responsible for siting and routing. They will provide opportunities for public input before making a final decision. The CPUC may or may not select the route we are proposing.

Project milestones

2014	California Independent System Operator (CAISO) approved the project scope submitted by PG&E
2015-2017	Project team conducted multiple rounds of open houses to obtain feedback on the project study area, potential transmission line corridors and potential route options
2017-2018	CAISO reassessed the project scope and approved a reduced project scope
2019	We relaunched siting and routing outreach on the revised project scope, including open houses
2023	We completed siting and routing and environmental assessment for our permit application
2023	We filed the permit application with the California Public Utilities Commission (CPUC)
2023-2025	CPUC review process with opportunities for public involvement, including an environmental review under the California Environmental Quality Act (CEQA) and the CPUC review of the project need and cost
2025	Anticipated CPUC final decision
2026-2027	Anticipated construction planning and construction start
2029	Project expected to be operational
