



## Building a cleaner, safer energy future

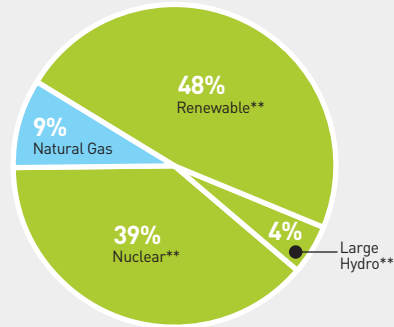
